### THE BUCHU ASSOCIATION

The Buchu Association (BA) is a collective working to promote, protect and support the growth of a sustainable Buchu Industry, inclusive of all its stakeholders.

The BA has as its vision the creation of a resilient and vibrant Buchu Industry able to take advantage of global market opportunities and create value for all involved through the implementation of the following objectives:

- To support and protect the members of the Buchu Association to enable them to give optimal effect to the envisioned actions and activities of the Association
- To represent the Buchu Industry on regulatory level in a strategic manner and to engage proactively with relevant parties on national and international level to protect and promote the interest of the Industry
- To support and strive for the creation of a stable and sustainable environment where the Buchu Industry can thrive and grow
- To develop and implement strategies to protect and enhance the natural environment and biodiversity crucial for the continued success of the industry and the protection of the Buchu plant as part of the indigenous resources of South Africa

Underpinning the mission, vision and objectives of the BA is a deep commitment to ethical behaviour in all areas where the BA may be involved.

## BUILDING A FAIR AND ETHICAL INDUSTRY

### **COLLABORATION**

The BA believes that strong networks will create a supportive environment conducive to the growth and development of the sector. For this reason, the BA s committed to being a unified voice to engage with both the national and international regulatory environments in the interest of the industry.

#### CARE FOR THE ENVIRONMENT

The BA has a deep understanding and respect for the relationship between the Buchu plant and its environment. Buchu producers and processors alike, realise the importance of holistically looking at the interaction between the environment, communities and business sustainability within the industry.

The BA believes that environmental stewardship is a combination of knowledge of how dependent we are on the environment for production of Buchu. The BA advocates for the adoption of holistic practices inclusive of cover ecosystem conservation, wildlife protection, water and soil conservation and agrochemical reduction to ensure that the environment is taken care of.



The members of the BA undertake to collaborate both with one another and external parties to ensure that the environment where Buchu naturally grows and is cultivated is protected. If risks to the industry is identified, the BA will develop and implement strategies to ensure that these risks are addressed and the possible negative impact on the industry as a whole mitigated.
